

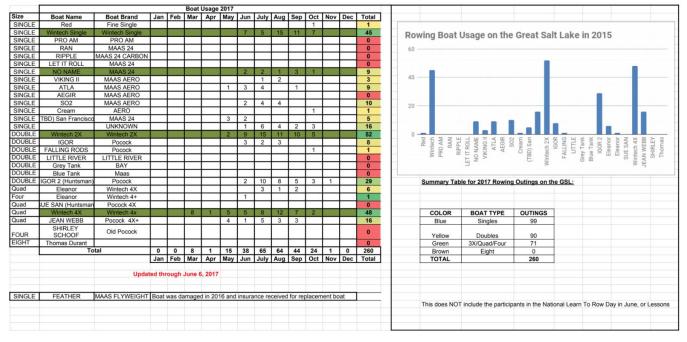
GSLR Board Meeting Minutes – Saturday, January 6, 2018 6pm @ Joann's, Salt Lake City

6:15 - Administration: Irene

 - b. Drafting a funding proposal for replacing the old dock with either full State funding or
 - maybe cofunding between GSLR & State (should have draft by 17 Jan 2018 or so)
- 3. Boat waxing session 11 Nov 2017 went well
 - a. Monitoring the performance of the wax cleaner during 2018 Q1 & Q2
 - b. Appears to be beading water on the hulls pretty well
- 4. Monitoring rack cushions during 2018 Q1 & Q2
 - a. So far holding up to the weather
 - b. Better securing method will be used in 2018 if same materials selected for cushion
- 5. Wooden Shed
 - a. Must stay until end of 2018 Q1
 - b. Continue to sort equipment & materials prior to demolition
 - c. Continue to clean & organise boathouse
- 6. Old Dock
 - a. Work is anticipated during 2018 Q1 & Q2
 - b. Initially an inventory of work to do salvage old dock for 2018
 - c. Developing a proposal to cost share a replacement dock with UDNR-DSP&R
- 7. Irene & Nicole C. to look into the Utah Outdoor Recreation Grant see if it can be used for a new dock or expanding the program into other areas.
